

## **Topic 1.1.1 2025 - Context**

NBS implementation is key for the Mediterranean region to:

Achieve water security/susta inable water management

Address extreme events, water pollution, and other hazards

Enhance ecosystem resilience, biodiversity

Evidence on the costefficiency, benefits and impacts of NBS still fragmented



Lack of holistic approaches and guidelines for their uptake at large scale

Pressing need to demonstrate the effectiveness of combining different NBS



## **Topic 1.1.1 2025 - Scope**

• Identify NBS for different ecological and socio-economic contexts to address floods, droughts, water pollution and other hazards, the barriers to acceptance, and ways to redefine regulatory frameworks

• Test, validate, assess cost-effectiveness and benefits, and scale up NBS while improving ecosystem biodiversity and resilience, recharging aquifers and preventing soil salinisation and erosion

• Business models, governance approaches, and recommendations for NBS adoption and integration into policies, environmental and land use regulations

• NBS combination incl. with other kinds of solutions (hybrid infrastructure)

• Decision support tools for NBS selection based on environmental conditions and stakeholder needs








